DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ IT IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS EFFECT.

POLICIES, PROCEDURES AND RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

In consideration for my dog being permitted to be a client at a Bark Palace Doggie Daycare Kennel and Spa, LLC (BP) for day or overnight boarding, I make the following representations and agree to all of the following policies, procedures, terms and conditions:

- 1. **CLIENT REQUIREMENTS.** My Dog meets the following requirements he/she: has successfully completed the Canine Behavioral Interview; is four (4) months of age or older; he/she is spayed or neutered (if over six (6) months of age); is current on his/her Rabies, Distemper and Bordetella vaccinations; is in good general health. is not aggressive or protective of toys; meets all other municipal or state licensure and other requirements. I have completed the Application and have provided BP with a current and valid credit card number. My Dog will enter and exit the facility with a leash.
- 2. **DOG FOOD**. Bark Palace will provide our quest with food in accordance with the instructions provided in the quest Application.
- 3. **PERSONAL PROPERTY.** I agree that BP shall not be responsible or liable for any lost, stolen or damaged personal property belonging either to me or my Dog. I also understand and agree that my Dogs collar will be removed in the play area to prevent injury to any dog. If my Dog causes any damage to the BP facilities or equipment, I agree to be fully responsible for the full cost of any repair or replacement.
- 4. **CLIENT FEES**. I agree to pay for all fees, services and products with the credit card number I have provided in the Application, or by cash or check at the time I pick up my Dog after each visit to Bark Palace. I give my express permission for BP to charge any of the credit card numbers I provided on the Application for any unpaid camp fees, services or products. I further agree to pay the cost of any check or debit charges returned or challenges for to any reason.
- 5. **CANCELLATION POLICY.** I understand that I will be charged for a full day of boarding, if I fail to cancel my boarding reservation at least forty eight (48) hours in advance; or, if my reservation falls on a designated holiday by BP, I must cancel three days (72 hours) in advance. If I fail to cancel a reservation for a boarding during a holiday period I will be charged for two days.
- 6. **REFUNDS.** Refunds are subject to management approval.
- 7. **AGGRESSIVE DOGS.** My Dog is not aggressive. Although BP loves all dogs, I understand that aggressive dogs are not permitted to attend BP and that if my dog acts aggressively or exhibits unacceptable behavior he/she may be separated from the other Dogs. BP will use reasonable efforts to consult dog's guardians about aggression and ways to address it, however aggressive dogs may be asked not to return to Bark Palace. Such determinations shall be made at the sole discretion of BP.
- 8. **ABANDONED DOGS.** BP is a place where all dogs are loved. No Dog may be abandoned at Bark Palace. I agree that I will not neglect to pick up my Dog from BP by the time he/she is scheduled to leave without providing notification. Any dog that is left at BP without any contact, instruction or notification from me, of the ability, willingness or plans to pick him/her up by myself or my personal representative or agent, will be considered abandoned upon the seventh day of such notification failure. I understand that if I abandon my dog at Bark Palace, BP by default, becomes the legal owner and guardian of the dog. BP will, in its sole discretion, determine whether to try to rehome and adopt the dog at which he/she was abandoned or will relinquish the dog to an unrelated shelter of its choice. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY DOG AT BARK PALACE I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY DOG AND WILL HAVE NO RECOURSE AGAINST BP.
- 9. **DUTY TO DISCLOSE.** I have disclosed and shall continue to disclose on an ongoing basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my Dog ability to participate in play time or otherwise attend BP.
- 10. **DOG PARTICIPATION.** I understand participation in play time is at the sole discretion of BP and that Dogs may be separated from other Dogs or asked to leave for any reason is sole discretion of BP.
- 11. ACCEPTANCE AND ACKNOWLEDGEMENT OF <u>PARTICIPATION RISK</u>. I FULLY UNDERSTAND THAT: (a) THERE ARE INHERENT AND POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND DOGS, AS WELL AS BETWEEN DOGS AND OTHER DOGS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR DOG; AND (b) THERE MAY BE OTHER RISKS NOT KNOWN TO ME NOR READILY FORESEEABLE AT THIS TIME (COLLECTIVELY, "RISKS"). I FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS, INCLUDING, WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF MY OR MY GUEST'S PARTICIPATION IN CAMP, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BEHALF OF MY DOG. SICKNESS SHALL BE DEFINED TO INCLUDE ANY ILLNESS INCLUDING BUT NOT LIMITED TO BORDETELLA (KENNEL COUGH) OR ANY OTHER FORM OF CONTAGIOUS ILLNESS.
- 12. **VETERINARIAN LIABILITY AND CARE.** I agree to allow BP to obtain medical treatment for my Dog, if, in its sole discretion it appears that, he/she is ill, injured or exhibits any other behavior that would reasonably suggest that my Dogs may need medical treatment.

If a Dog passes away at BP, it will be brought to its or the nearest veterinarian. I AGREE THAT I AM FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT, AND FOR THE COST OF ANY TRANSPORTATION FOR THE PURPOSES OF SUCH TREATMENT, PROVIDED TO MY DOG.

13. WAIVER, RELEASE AND INDEMNIFICATION. I HEREBY EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND AND COVENANT NOT TO USE BP, and their invitees, sponsors, advertisers, owners, officers, directors, employees, volunteers, invitees, agents, leasers, and any parties owning, controlling or having any interest in the property at which the Event is taking place, and all other representatives or agents (the "Releases") from and against ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, EXPENSES OR DEMANDS (including reasonable attorney's fees) OF EVERY CHARACTER WHATSOEVER on account of, arising out of, resulting from or relating in any way to (i) any act or omission of the Releases, including negligence, and/or my Dogs participation in activities at Bark Palace, or otherwise. I FURTHER AGREE TO INDEMNIFY, SAVE AND HOLD HARMLESS the Releases from any claims, litigation, actions, suits, damages, costs, attorney's fees, losses or injuries as the result of any such claim. I AGREE THAT THIS RELEASE SHALL BE BINDING ON ME AND MY SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS. I ALSO EXPRESSLY AND FOREVER RELEASE BP FROM ANY DUTY TO PROTECT ME OR MY DOG(S) FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF BP CHOOSE TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASE BP. FROM ANY DUTY TO PROTECT ME OR MY DOG(S).
